### **Suggested timeframes to arrange for the clearance & delivery to the site**

- Airfreight shipments to Abu Dhabi / Dubai - 5 days before the delivery date required
- FCL shipments to Abu Dhabi / Dubai - 8 days before the delivery date required
- LCL shipments to Abu Dhabi / Dubai - 10 days before the delivery date required

### **Notes to Tariff**

- All rates are quoted in U.S. Dollars.
- Our tariff is based on 10 working hours, with one hour lunch break. In the event of additional working hours, overtime surcharges on pro-rate basis shall apply.
- Special handling / services / transportation if required, then the charges for the same will be additional based on the scope of work. Please advise us the details of such shipments prior to the dispatch from origin.
- **Value Added Tax** - Effective 01<sup>st</sup> January 2018, 5% Value Added Tax (VAT) is applicable for all services and charges in UAE as per UAE FTA Law. VAT is not applicable in the event of freight is booked through Agility.
- Shipments can be customs cleared with copy of Combined Commercial Invoice & Packing List or without Certificate of Origin by paying US\$ 355.00 (Document deposit US\$ 280.00 + Service fee US\$ 75.00) per missing document set as customs deposit. Upon receiving the relevant original document within 7 days from arrival date into UAE & if accepted by the customs authority, the deposit of US\$ 280.00 can be refunded subject to approval from customs.
- First 7 days / 4 days from arrival of freight into Abu Dhabi / Dubai airport respectively is free thereon US\$ 0.05 cents per kg per day will be levied + 10% service fee.
- For early arrival shipments, storage charges will be applicable (irrespective of the cargo arrival deadline mentioned in the shipping manual). The free time permitted for the shipments to Abu Dhabi / Dubai seaport is 5 days from the shipping line/consolidator and 10 days from the Port authority effective from the date of arrival. Estimated charges (vary from liner to liner) as under.

- For reefer containers, first 3 days will be free and thereafter port / line demurrage charges will be applicable as above (subject to change).
- Plug-in charges will be applicable for reefer containers from day one at the port @ approx. US\$ 35.00 per container per day (subject to change).
- Re-export shipments must be routed via the same port of entry for the inbound shipment. The re-export shipments and the documents must tally with the inbound details otherwise customs duty will be applicable on final basis.
- Customs duty will be applicable on final basis for fuel, tyres, consumables, giveaways, non-return items etc. @ 5% of the CIF Value assessed by the Customs Authority + VAT.
- Customs deposit has to be paid for the shipments arriving via Dubai Airport/ Jebel Ali seaport/ Road freight shipments via UAE Border Customs.
- **Cancellation of Temporary Import Bond:** As per Customs Authority in Abu Dhabi, effective 01<sup>st</sup> January 2018, Temporary Bond cancellation fee is applicable @ 1% of the customs deposit amount. Minimum US\$ 65.00 per shipment and Maximum US\$ 450.00 per shipment.
- Import Freight arrived under different AWB's / BL's if re-exported together with other freight by sea or air then US\$ 150.00 towards Customs documentation will be applicable additionally.
- Transportation of sea freight containers includes return of empty containers to the port. Free time permitted for off-loading or loading at site will be 3 running hours and thereafter trailer detention charges @ US\$ 40.00 per hour will be applicable.
- If the container has to be grounded and the empty container to be delivered to the Abu Dhabi / Dubai port later or vice-versa, then additional transportation charges @ US\$ 450.00 per container per trip will be applicable.
- Transit Cargo Insurance has to be arranged by shipper or consignee on door-to-door basis including stay at site. Contractors/ Transporter shall be included as coinsured/sub-contractor in the policy and cover all liabilities with an express and unconditional waiver of subrogation towards contractor/ transporter. The insurance policy must waive the right of recovery from transporter fully and unconditionally. We can arrange the insurance and the applicable charges will be additional.
- Forklifts/ Crane / Labor required for off-loading/loading, packing/un-packing or other requirements, then applicable charges are based on minimum 10 hours and thereafter overtime charges will be applicable on pro-rate basis.
- Securing / Packing materials if required, then the charges for the same will be additional.
- Customs fine, other official charges, if any will be additional at actual + 20%
- Pro forma or Shipping Invoices are not acceptable by the Customs Authorities in UAE.
