2023 SR 080.3. 1. Publication

Emirates Motorsport Organization (EMSO) is organizing the second round of the 2023 FIM World Rally-Raid Championship on behalf of the Emirates Motorsport Organization (EMSO).

The event will take place in accordance with the relevant legal and administrative requirements of the host country/ies and the relevant FIM documents, including but not limited to the FIM Sporting Code, the applicable FIM Technical Regulations, the FIM Medical, Anti-Doping and Environmental Codes, the FIM Disciplinary and Arbitration Code, the FIM Code of Ethics and the Sporting and Technical Regulations of the FIM Cross Country Rallies World Championship and the Appendices thereto, as well as the present Supplementary Regulations and any rules and regulations adopted by the FIM International Jury.

The present Supplementary Regulations may not be in contradiction with the FIM Rules and Codes, including but not limited to the Sporting and Technical Rules applicable to the discipline. In the case of a divergence or conflict between these Regulations and any of the applicable FIM Rules and Codes, the latter shall prevail.







FIM Approval: IMN No(s) 801/02 for all categories

FMN Approval: EMSO-2023-229 Approved on: 13 January 2023.

In case of divergence or conflict of interpretation between the English and French versions, the English text shall prevail. The approved Supplementary Regulations must be published, at least in English, on the FIM website and on the site of the Organizer.

In any matter not covered by the FIM Cross Country Rallies World Championship Regulations or by these Supplementary Regulations, the FIM International Jury shall decide ex aequo et bono. All additional provisions of a technical or organizational nature not contained in these Supplementary Regulations will be announced by means of a numbered, dated and signed addendum. Such addenda will form an integral part of the Supplementary Regulations and shall be posted on the official notice board of the Rally. They will also be communicated during the riders' briefing and the riders will be notified in the shortest time practicable.

Each participant personally assumes the risks linked to Covid-19 by traveling to and participating in an event of this type and exonerates the organization of any medical situation that may arise from their participation.

2023 SR 080.4. 1. ADDC Entry procedure

Entries should be made using the official forms available on the website www.abudhabidesertchallenge.com

Anybody wishing to take part in the Event must send the entry form, duly completed, to the secretariat of the Event (entry@emso.ae) along with the entry fees and copy of all the documents requested.

Any person wishing to take part in the **2023 Abu Dhabi Desert Challenge** must send to the Secretariat the signed entry application accompanied by the amount of the entry fee that will be increased **by 50% for the riders/teams not accepting the optional advertising of the Organizers.**

The entry fee is valid to 23:59 on the 11th February.

Up to the time of the Administrative checks, the rider shall be free to replace the motorcycle entered. If a motorcycle does not correspond, in its configuration when presented for the technical Controls for Scrutineering, to its entry category, the motorcycle concerned may, on a proposal by the Technical Stewards, be transferred by the International Jury to another category.







2023 SR 080.4. 2. Customs obligation – ATA Carnet ATA CARNET IS COMPULSORY FOR TEMPORARY IMPORTATION IN THE UAE UNDER EMSO EVENTS.

10 DAYS BEFORE the goods leave for the UAE, the Competitors need to send to the Organization:

• A copy of the ATA CARNET (signed by the authorities of the country of the Competitor) will be requested by EMSO to prepare the temporary customs documents and facilitate the temporary import with the Shipping Agents. NO OTHER DOCUMENTS WILL BE ACCEPTED.

BEFORE TO ENTER THE VEHICLES IN UAE, THE ORGANIZER NEEDS TO RECEIVE THE ENTRY FORM COMPLETED WITH ALL THE DETAILS OF THE COMPETITOR AND THE VEHICLE WITH THE REGISTRATION CARD OF THE VEHICLE AND THE INSURANCE IF THE VEHICLE IS USED ON THE ROAD BEFORE AND AFTER THE RALLY.

AS SOON AS the goods are loaded:

• A copy of the FINAL AIR WAYBILL (transportation by air) or BILL OF LOADING (transportation by sea) and a copy of the vehicle registration need to be attached with the ATA Carnet.

2023 SR 080.4. 3. Team Entries

EMSO Team Entries / Award for Team Entries

Team entries must be composed of motorcycle and riders whose individual entries have been accepted. Each team may consist of **a maximum of 5 motorcycles and a minimum of 3**. The performance of the best 3 motorcycles will count for the final results. No motorcycle may be included in more than one team eligible for the same award. Each club, Team, manufacturer (represented by his Agent or Distributor in the UAE), may enter more than one team for the corresponding award, but for each award the same competitor may only be part of one team.

Motorcycles included in a make team may not necessarily have been individually entered by the same entrant. In such a case the written approval of the individual entrant must be produced. They must however, be of the same make but not necessarily of the same model or type.

2023 SR 080.4. 4. Team entries names

REMIND: According to the FIM Regulation, only the name of the Team with a valid 2023 FIM Team Licence will appear on the official entry lists, official's documents, Press release and official results during the event.

The Competitors need to apply directly to FIM for a 2023 Team licence.

All the Service Vehicles and Service Crews need to be registered.

A copy of the passport for each Service Crews member and the copy of the driving licence of the driver of the vehicle are requested.

COMPULSORY: All the Overseas Service Vehicles needs to be insured for UAE. See Article 080.5 – Insurance.

IMPORTANT

If the service vehicle is an overseas vehicle, the registration card of the vehicle needs to be sent with the entry form with all the documents of shipping: airway bill (Transport by air) – Bill of lading (Transport by sea), ATA Carnet, etc.







6. Entry fees for Rider, for Bike or Quad

The entry application will only be accepted if accompanied by the total entry fees.

CONDITIONS FOR UAE

Definition of UAE Entry: To be eligible for UAE entry rates, the Rider needs to be in possession of a UAE Passport or relevant UAE residence visa valid for at least six months.

In addition to a FIM Competition Licence issued by EMSO.

If the riders rent a Bike or Quad outside UAE, the UAE rates will be applied.

OVERSEAS Service Vehicles

Please note than the overseas vehicles are not insured in UAE.

The Organization will insure the vehicles registered on the event, if the Service Vehicle Form has been registered and the entry form correctly completed before 11th of February 2023.

A color copy of the vehicle registration (both sides) is COMPULSORY and needs to be sent with the entry form. The vehicle will be insured 2 days before and 2 days after the event. The customs formalities cannot be done without these documents.

Rental vehicle: Please note that UAE rental vehicle are on your own responsibility. Please check with the rental agency.

Please complete the Service Crews/vehicle registration form and send back to entry@emso.ae along with your competitor entry forms before 11th of February 2023. A copy of each passport needs to be sent with the Service Crews form and the driving licence.

Please note that the EMSO will no longer organize UAE visas for Service Crews.

Instead an 'Invite Letter' can be prepared upon request by email to entry@emso.ae.

Please note than this letter will not cover any expenses during the stay in UAE in case of accident, hospitalization and / or repatriation.

Each Service Crew member needs to have their own travel insurance during his stay in UAE. This letter cannot be used for Customs Formalities (Temporary Importation).

2023 SR 080.4. 8. Payment details

The entry fee for Overseas Competitors, as laid out in these Regulations, is inclusive of Repatriation and Medical insurance.

2023 SR 080.4. 9. Abu Dhabi Desert Challenge Entry Incentive

To encourage greater women entries, it has been agreed that any single women motorcycle entry may be eligible for 25% off the published entry fee. This discount may not be combined with any other discount.

Abu Dhabi Desert Challenge & Dubai International Baja (Dates TBC, 2023) Incentive

To encourage greater entries at the two international events in the UAE, it has been agreed that any competitor participating in the two events in (2023 Abu Dhabi Desert Challenge and 2023 Dubai International Baja) will be entitled to a **50% discount** on the entry fee for the Dubai International Baja event (service and media fees are not included).

This refund of 50% of the entry fee will only be refunded once the competitor has been confirmed to start both events. The refunds will be processed by the EMSO accordingly.

This discount is applied upon the competitor, not the vehicle. For example, a competitor who does each of the events in a different vehicle will be entitled to a discount, while one vehicle which is used by a different competitor on each event will not be entitled to a discount. 2023 SR 080.4. 10. Refunds

2023 SR 080.5. 2. Overseas & GCC entries Cover

An accident & Sickness Emergency Medical and Repatriation expense is included in the entry fee to a level of **AED 626,000 (\$170,000 / EUR 159,000).**

1. Search and rescue costs

The assistance and search and rescue costs are borne by the local rally organiser.

2. Medical expenses

The medical expenses are borne by the rally local organiser up to **EUR 10,000**.

3. Medical evacuation (hospital to hospital) and medical repatriation

The organisation and costs are borne by the rally local organiser up to **EUR 40,000**.

2023 SR 080.5. 3. Declaration in case of accident

In case of an accident, leading to an insurance event, the competitor or his representative must make a written statement to the Clerk of the Course, the Competitors Relations Officer, or directly to the Organizer, within 24 hours. This statement must mention the accident circumstances, the names and addresses of the casualties, as well as contact. Any breach of this rule will be reported and may result in a penalty, at the discretion of the Jury International.







Nevertheless, if a driver taking part in the rally is involved in an accident in which a member of the public sustains physical injury, the driver concerned must report this to the next radio point as specified in the road book and point the place on the route. If he fails in observing this rule, the Stewards may impose a penalty to the responsible crew, which may go as far as disqualification.

2023 SR 080.5. 4. Individual accident insurance

It is highly recommended to take out additional individual accident insurance, which may allow the Competitors to cover additional costs, with an insurance company of their choice.

2023 SR 080.5. 5. Insurance included in your FIM Licence

Competitors with a valid FIM Licence are covered for Emergency Medical treatment as per the FIM Riders' insurance information enclosed (see appendix 5).

2023 SR 080.5 6. Medical insurance rules in UAE

It is important for all Competitors to fully understand the situation with regards to the Medical expenses according to the UAE rules.

In the event that "you" the registered competitor have an accident during the event and requires medical attention in a hospital then the following procedure needs to be followed:

• On release from Hospital any **Medical costs** <u>MUST</u> be settled by you or third party before leaving the hospital. The hospitals have been informed of this arrangement.

In case of accident, a claim form will be sent to you or third party by email, which needs to be completed along with the Hospital report and receipt.

Once received and verified, then these documents are forwarded onto our Insurance Company for review and process.

Please note than there is an excess applicable of USD 2500 to all insurance claim. By the fact to sign your entry form, you fully understand the above, and that Medical costs must be settled before leaving the hospital.

The Organizer is not responsible for any settlement of the bills.

2023 SR 080.5 7. Road insurance for Overseas Service Vehicles

Competitors are reminded that Service Vehicles that are registered overseas, **entering by boat, by air or by road, are not insured in the UAE**. The Organizer is able to ensure such vehicles for the duration of the event, provided that said vehicles are registered with the Organization utilizing the official event SERVICE VEHICLE REGISTRATION FORM and notably, also submitting a clearly scanned color copy of the vehicle registration certificate (all pages/both sides). All documents will be verified at Administrative Checks.

At the organizers discretion, a separate fee may be charged for each Service vehicle that would require insurance in the thirty days leading up to Documentation.

Competitors are furthermore reminded that UAE Rental Vehicles and all insurance related obligations are the sole responsibility of the competitor.

FIM 080.6 ENTERED RIDERS

2023 SR 080.6. 1. Entry conditions for the Rider

- The Organizing Committee reserves the right to refuse the entry of a rider.
- To be registered in 2023 Abu Dhabi Desert Challenge, any person from any country must hold an FIM Cross-Country Rallies World Championship or World Cup licence released by his own National Federation in accordance with art. 70.2.1 of the FIM Sporting Code and







Art. 09.1 of the FIM Medical Code.

To obtain this licence from his national federation, the rider must undergo and pass successfully an echocardiogram, once in his lifetime and an exercise tolerance test (ECG) valid for three years.

- The rider must obligatorily be a holder of a valid driving licence corresponding to the type and capacity of his/her Bike, Quad.
- ONLY FOR UAE Citizens and UAE Citizens holding a valid resident visa's:

Following the UAE laws, a person between 16 and 18 years old can obtain a driving licence to ride a bike or a quad in UAE. EMSO can process a 2023 FIM Licence for the event for eligible people. The procedures for holding a competition licence are the same as any other competition licence issued by the EMSO.

To complete the entry for the event, the competitors' parents have to sign the entry form of the event, and submit a signed waver stating their no-objection to enter the 2023 ADDC.

- Any copy or statement of loss or theft of the previously mentioned documents will not be accepted, as it does not legally substitute the possession of a driving license conforming to the capacity of the motorcycle.
- Any rider who is replaced by another one on his motorcycle during the race will be excluded from it, as well as the motorcycle of this last-mentioned driver.
- The Rider is responsible of the behavior of his mechanics; his assistants, his manager, his Press staff and any infringement to the regulations will be borne by the Rider.
- The maximum number of motorcycles accepted is 100.

The rider enters the 2023 Abu Dhabi Desert Challenge at his own risk, being fully aware of the danger associated with the event. For this reason, the rider relieves the Organizer, the FMNR and the FIM from any penal and/or civil responsibility in case of physical and/or material damages incurred as a result of his participation in the event. He/she agrees to indemnify, protect and hold harmless the Organizers, the FMNR and the FIM and anyone acting on their behalf or under their authority, including but not limited to their representatives, employees, agents, officials and volunteers, from and against any and all liability, penal and/or civil, loss, expense or claims of whatsoever nature, including but not limited to third party claims, relating to injury to persons, including death, or loss or destruction of or damage to property arising in connection with his/her participation in the 2023 Abu Dhabi Desert Challenge.

By the fact to sign your entry form and the Administrative/Scrutineering carnet, you fully understand and accept the above.

2023 SR 080.6. 2. Cover Images – Image rights

- The Riders & his Team recognize that the 2023 Abu Dhabi Desert Challenge is a promotional operation from which they can benefit by the coverage they acquire there.
- The Organiser holds all the rights necessary for the production and retransmission, by all means and in all mediums, all over the world, images and sounds related to this event.
- In order to allow the widest possible dissemination and promotion of the 2023 Abu Dhabi Desert Challenge, any person participating in the Rally is subject to the rules and acknowledges that his participation in the event authorizes the organizer and his rights holders, or others having cause to reproduce and represent, without remuneration of any kind, his names, voice, image, biography and more generally his sports performance in the framework of the Rally 2023 as well as the brand/s of its suppliers, manufacturers and sponsors, in any form, on any existing or future medium, in any format, for any communication to the public worldwide, for any use including for advertising and / or commercial purposes without any other limitation than those referred to below, and for the duration of the protection currently granted to these holdings by the laws or regulations, the judicial and/or arbitral awards from any country as well as current or future international conventions, including any extensions that may be made to this duration.
- The participants concede to the Organiser, in name and on behalf of their sponsors and/or the







manufacturer of their vehicle, the right, as part of any exploitation derived from the event, including sponsors and media of the event, to reproduce in whole or in part at the discretion of the organizer on any existing or future support, worldwide, without any limitation, for the most longest duration legally recognized by both UAE and foreign laws, current or future international conventions including for any extensions that may be made to this duration, names, trademarks or logos of said sponsors and / or visual machines/vehicles.

 - 1 single travel bag, identified with the Rider's number.

No material other than those listed above will be transported by the Organizer.

2023 SR 080.7.4. 1. Identification

1 - Number plates & advertising stickers

The Organizer will provide to each rider a set of identification plates comprising 1 front plate and 2 side plates, called number plates and advertising stickers at Documentation.

Size according to FIM rules: Moto-Rally 25 X 18 cm and Quad 28 X 18 cm.

The absence of or incorrect affixing of a racing panel or plate shall result, for each offence noted, in a time penalty as stated in the Supplementary Regulations.

2 – Bib number plates

The Organizer will also provide at Documentation one bib measuring **26 cm x 30 cm,** bearing the racing number which should be clearly worn on the rider's back during the Rally.

The race bib cannot be cut and/or modified, not hidden by anything like a 'camel bag' and shall always be visible.

Before the start of each stage, the simultaneous absence or incorrect affixing of at least two racing plates or bib shall result in disqualification from the Rally.

In case of damage, the Rider must inform the Competitors' Relation Officer, who will provide a







replacement in exchange for the damaged item.

3 - Wristband

An identification wristband will provide identification for the rider. All default noted by an official will result in penalties equivalent to 10% of the entry fees.

In case of damage to the bracelet, the rider must inform the Competitors' Relation Officer, who will provide a replacement in exchange for the damaged item.





It is the rider's responsibility to ensure that the position of their bibs allows complete visibility of the rally number.

A financial penalty will be imposed if the above is not complied with.

- Gives a mobile telephone number valid in UAE to be contacted directly during the race.

Prev (1000 m) = previous waypoint or within a radius of 1000 m if the previous waypoint was missed.

1000 m (Prev): Within a radius of 1000 m or previous waypoint by the shortest distance.

At each waypoint, the odometer must be recalibrated automatically.

2023 SR 080.11. 3. Navigation rules

Throughout the rally, each Rider is responsible for the correct functioning of his GPS, downloaded with the Organization's points. The GPS must be connected to the power source at all times (Liaison & Special).

Each malfunction must be communicated to Clerk of Course or the CRO. Any evidence of manipulation may be penalized as far as disqualification from the rally as determined by the International Jury.

2023 SR 080.11. 4. Road Book

All the riders will receive a Road Book (roll) in BIKE Category.

The Electronic Road book for 2023 Abu Dhabi Desert Challenge is compulsory ONLY for the OUAD Category.

Remind: The only official route is the one in the Road Book.

The GPS Code of each stage will be display at the Bivouac exit every morning.

The road book of the road section before the Special Stage will be distributed to each rider every morning before the start from the bivouac.

The road book of the stage will be delivered to each Rider every morning before the start of the Selective Section. The distribution will be preceded by a Time Control, 25 minutes before the scheduled start time of the Selective Section. It will be followed by a second Time Control, 20 minutes (15 minutes + 5 minutes) before the scheduled start times in the Selective Section.

Please note:







The addition of any information on the road book, bike and pilot:

- Cap(s)
- Geographic(s) indication(s) that could be useful for navigation
- Distance(s)
- GPS point(s)

Different from the ones already on the road book itself and on the opening notes provided by the Organization are strictly forbidden.

Controls will be operated. The road book used by the Rider or the Crew members will have to be given in full upon request at the end of the Special or Road Section to the Marshal or officials in charge of their collection.

Any Pilot or Crew who does not respect those rules will be sanctioned by:

1st infraction: 3 hours penalty2nd infraction: Disqualification

Any missing or lost road book will be considered as an infraction.

2023 SR 080.11.8. 1. General & Daily Briefings

It is compulsory for all Riders to attend the First General Briefing (See programme) conducted by the Clerk of Course Auto. A penalty of €200 will be incurred if the Rider is not present.

It is strongly recommended to attend the following daily briefings at 19h00.

2023 SR 080.11.8. 2. Safety Systems Briefing

A compulsory briefing for the Riders where the use of the various safety systems will be by presented by MARLINK / ERTF representatives on Saturday 25th February 2023 at 18h00 at The Energy Business Center.

The name of the riders participating will be posted on Sportity and inscribed on an attendance list.

2023 SR 080.11.8. 3. FIM Education Program for New Riders

A compulsory training (Max. 45 min.) for new riders will be organized on 25th February 2023 at 15h00, same location than General Briefing.

FIM 080.12 ROUTE

2023 SR 080.12. 1. Forbidden Reconnaissance

Any form of reconnaissance of the route, whether by a Rider himself or any party associated, directly or indirectly, with a Rider is strictly prohibited.

The possession of route notes, other than those issued by the Organizers of the 2023 Abu Dhabi Desert Challenge, or the storage of GPS waypoints from previous years' events is prohibited. Competitors who fail to observe these bans will be refused a Start or will be disqualified from the event. A commercially available map, free of any markings, other than those deduced from the Organizer's road book couldn't be carried on board a competing vehicle.

2023 **SR** 080.12. 2. **Private tests**

Riders who wish to perform private tests during any part of the year are obliged to notify the Organizers of their intentions, with details of dates/timing and obtain written permission. On application, areas within which it is permitted to test will be advised to the applicant.

2023 SR 080.12. 3. Traffic regulations

2023 Abu Dhabi Desert Challenge is divided in 5 stages with road sections.

Throughout the duration of the Rally the Riders must strictly comply with the traffic regulations of the UAE and stay on the road book Any competitor who does not comply with these







requirements will be penalized according to the FIM Article 80.12.

If the Police stop a Rider, the Rider needs to inform immediately Rally Control. Keep calm. An Arabic letter will be given at Documentation to show to the Police in case they stop you.

2023 SR 080.12. 4. Crossing of inhabited areas

Riders

Along inhabited areas crossed in the liaison sections as well as along the Specials, the speed will be strictly limited as specified by the local sign panels. All areas that are considered dangerous for riders and for local inhabitants will be indicated in the road book.

• Assistance: Service Vehicles

The speed of all assistance vehicles in crossed cities and villages, following the assistance road book, will be limited as specified by the local sign panels. Overtaking is also forbidden. The Organizing Staff will make controls and the International Jury can decide penalties.

FIM 080.14 PROLOGUE

The Competitors are allowed to transport their bike or quad on a trailer or inside a service vehicle for the free road section between The Energy Business Center and the regrouping Park before the prologue. The vehicles need to stay on the itinerary of the road book.

2023 SR 080.14. 1. Prologue location & procedure

A Prologue will be organized immediately after the start ceremony on **26th February 2023 at 15h10 (First bike)**.







Distance will be between 6,43 km. Sand Terrain.

Location is next to the Regrouping Park and around 6 km from Al Dhannah Bivouac.

Maximum time: 15' (X8) Will be announced on bulletin no. 1

The 15 minutes will be applied to anyone who does not finish or are not able to start the Prologue.

!!! Competitor's will received a time card at the entrance of the Regrouping Park with a road book to go to Al Dhannah Bivouac after the Prologue.

The maximum speed on road section is according to the speed indicated by the road signs.

The time control of the road section will be at the entrance of the Al Dannah Bivouac.

Starting Order for Prologue

The starting order will be every minute in reverse order of the classification of the World Championship for the RallyGP and in the reverse order of the number for the others riders.

The result will count for the classification of the event as well as any road penalties related thereto.

A multiplying factor of 8 will be applied to each time of the Prologue.

The recce of the Prologue is permitted on a non-motorized bicycle or by foot. The schedule and details will be published in Bulletin no.1

FIM 080.15 SELECTIVE SECTORS (SS)

2023 SR 080.15. 3. Distance of the Selective sections

The km of each stage will be the same for all the Categories: RallyGP, Rally2, Quads.

FIM 080.17 STARTING ORDER

2023 SR 080.17.1. 1. Minimum interval between the last Bike/Quad & 1st FIA car

At the start of the stage (Bivouac exit), under no circumstances will a bike/quad rider be allowed to start more than 30 minutes after the theoretical start time of the last bike/quad.

At the start of the Special Stage, a bike/quad rider won't be allowed to start once the first FIA Car in the race has left.

2023 SR 080.17.3. 1. First Stage

According to 2023 FIM Regulations Article 80.17.3

From 30st position onwards the starting gap will be 30 seconds.

2023 SR 080.17.4. 2. Second and subsequent Stages

The starting order of Stage 2 and the following stages will be established in the order of the scratch classification of the Selective Section, or of the accumulation of the Selective Sections of the previous day.

2023 SR 080.17.5. 1. Last Stage

The starting order of the Last Stage will be left to the discretion of the organiser and published







in the SR. It is not possible to leave the choice of starting order to the riders.

2023 SR 080.17.6 1. Collective Start (Mass Start)

There will be no mass start.

2023 SR 080.17.7 Marathon Stage

The stages for the Marathon stage will be day 2 and day 3 of the rally.

TYRES

For **RALLYGP:** The tyres will already have been marked during scrutineering but the Scrutineers will have to mark the wheels.

For RALLY2 & QUAD: The tyres will be marked at the end of day 1 at the Bivouac between 20h00 and 22h00.

Location and penalties will be notified in the bulletin no. 1.

Inside the Marathon Work Park, riders can swap out parts except for tyres and wheels.

No assistance allowed to be present on the itinerary (Road Section and Special Stage) during day 2 and day 3.

Services vehicles and services crews must stay at Qasr Al Sarab bivouac.

2023 SR 080.17.7. 1. Work Park Marathon location and procedure

Location:

The Work Park Marathon will be located on the left side, after the main entrance of the Bivouac. (next to the refuelling area).

Environmental mat flap is compulsory in the Work Park Marathon.

A service crew, before the arrival of the first rider, must place the mat flap inside the Work Park Marathon.

Procedure

Immediately after the finish of the leg 2:

- Riders refuel the machine at the truck of the Organization. The riders cannot work on the machine in the refueling area. (Refueling will be not allowed in morning of leg 3).
- Enter into the "Work Park Marathon". The controlled area will be spilt in 2 zones:
 - one for RallyGP,
 - one for Rally2, Quad and category 4.
- RallyGP will have 30 minutes to check the machine and change the air filter. No help from outside but help between riders in this category is allowed. EXCEPT for tyres, the riders can share parts with riders in this category.
- Category 2 and Quads will have 60 minutes to check their machine and change the air filter. No help from outside but help between Riders from these categories is allowed. EXCEPT for tyres, the riders can share parts with riders in the same category.

After these minutes of work, the rider will have to go outside the Work Parc Marathon. There is no possibility to come back in this Parc.

Riders are allowed to go to sleep at the Hotel next to the Bivouac.

• In the morning of Leg 3, the Rider will be allowed to enter in the Work Park Marathon 15 min. for RallyGP and 30 minutes for RALLY2 and Quads before his start times and will be released from the Work Park Marathon 5 minutes before his check time at the TC. The Rider will receive the Road Book at the TC at the entrance of the Work Park Marathon.







2023 SR 080.17.8 1. Change in the start order - Repositioning

According to 2023 FIM Rules, Article 080.17.8

The request needs to be given to the Clerk of the Course before 17h00 by the Rider or the Team Manager.

2023 SR 080.17.9 1. No start or abandon in a Selective Section / Stage REMINDER

A rider not present at the start of a Stage and who did not inform the race direction in any manner will be disqualified.

The rider who does not wish or cannot start a Stage must still present himself, be represented by somebody at the start of the Stage or have informed the Clerk of the Course before the start of the Stage. In this case, he will receive a penalty as follows:

• Six (6) hours + Stage Penalty (SP) + Maximum time of the Selective Section + the value of all waypoints not validated.

The rider who starts a stage and then leaves the Stage Selective Section will receive the following penalty:

• Three (3) hours for having left the stage + SP + Maximum time of the Selective Section + the value of all waypoints not validated.

2023 SR 080.17.11 1. Openers bonus

The stages using the opener bonus will be: Stage 1, stage 2, stage 3 and 4.

FIM 080.18 ASSISTANCE, TOWING AND REFUELLING

2023 SR 080.18.1 1. Forbidden Assistance

Refuelling

Assistance in the refueling zone during the 20 minutes is forbidden.

Service crews and service vehicles are not allowed to go to the refuelling points.

Assistance is forbidden at the refueling zones and during the Special Stages.

A penalty of 6 hours will be applied to the Rider for any sort of assistance NOT ALLOWED.

Assistance (Service crews and Service vehicles) is ONLY permitted at the finish of the SS according to the profile of the Leg (except Marathon day 2 and 3) and at the Bivouac. This information will be announce at the briefing the day before the stage.

2023 SR 080.18.1 2. Tyres

PADDLES tyres are not allowed for the 2023 Abu Dhabi Desert Challenge.

2023 SR 080.18.1. 3. Transport from The Energy Business Center to Al Dhannah Bivouac then to Liwa Bivouac

Organizer's trucks can transport a box containing spare parts, special equipment, two/three tyres and wheels for each private competitor and riders registered in "Malle Moto".

Competitors should bring their own metal box (max dimension: 80cm x 45cm x 35cm height) identified with their competitor Number. The maximum weight allowed is 60 kg.

2023 SR 080.18.1 4. Team personnel / Service Crews

Each competitor is reminded that he/she is jointly and severally responsible for his or her service teams and accompanying persons. It's compulsory to register all the Service Crews.

Any infringements of the regulations, as published by the FIA and the Organizers, that are officially observed, as well as use of unauthorized equipment – whether or not this has a direct or indirect influence on the results or sporting running of the event – will be judged by the Panel of Stewards of the Meeting who will be entitled to decide as far as the disqualification from the event of the competitor(s) involved, directly or indirectly.

The ID bracelet, correctly attached to the wrist of competitors, crew and service personnel, is considered the only authorization to be present in an official location, service area and the bivouac. Personnel must show the ID bracelet at any time on request. A crew receiving assistance in any form from third parties not identified by the wearing of the ID bracelet are subject to a penalty of \$100 and up to and including disqualification.

For any infringement of this rule, a penalty of up to and including disqualification from the event may be imposed by the Jury on the competitor for whom the transgressors are servicing.

2023 SR 080.18.4. 1. Fuel / Autonomy

Each rider is responsible for calculating their fuel range to cover **the minimum distance of 250 km** for safety reasons a 10% margin is indispensable.

2023 SR 080.18.4. 2. Refueling during a Selective Sections

The neutralization for the refueling will be 20 minutes.

During the Neutralization for refueling, **NO** intervention on the bike/quad is allowed. The infringement of this norm will be penalized at the discretion of the Jury, and that may go up to exclusion.

2023 SR 080.18.4. 3. Automatic Control for refueling and neutralizationsThe neutralization period for refueling will be virtually controlled by the ERTF device.







After refuelling, the competitor must present himself at the end of neutralisation control marked by a red panel to make a new start, indicated by the end of the countdown on his GPS.

100m before the WP end of NEU, there will be a yellow sign, the competitors will be able to pass this sign only in the last 60 seconds of the time allowed for the NEU.

Approximately 100m after the yellow sign, a red sign will show the point where the WP indicates the end of the NEU.

Stopping at the red sign is mandatory.

Any rolling start will be penalised as follows according to FIM rules:

To stop at the red sign is compulsory. Any rolling start will be penalised with one minute penalty (1 minute).

FIM 080.22 PASSAGE CONTROLS

2023 SR 080.22.3. 1. Passage Control Penalties

All controls must be passed in the order defined by the Road Book.

Competitors are required to stop within the Passage Control Zone to have the Time Card stamped by the PC Controller. Failure to visit any Passage Control will result in a time penalty as in art. 080.22.

- Missing a CP ie missing the WPS: 120'
- Missing stamp at a CP: 5'

The controller at each PC will record the time of entry of each competitor in minutes and seconds. In the event the Special Stage is shortened, due to 'force majeure' the times recorded at the last Passage Control will determine the finish times of that Selective.

FIM 080.24 FIXED PENALTIES (PF) / SPORTING PENALTIES (PS)

2023 SR 080.24. 1. FP and SP value

- <u>A fixed penalty (FP) of 2 hours</u> will be applied to competitors who fail to complete a Section within the Maximum Time Allowed for that section.
- A Stage penalty (SP) of 2 hours will be applied to competitors who miss or fail to complete a Section.
- Maximum number of Stage Penalties for Rally2 and Quad: 1/one
- For RallyGP at the first Stage Penalty the rider is out of the race.

2023 SR 080.29.1. 1. GPS UNIK II with integrated Sentinel

The mandatory equipment is not included in the cost of the Entry Fee or ordered on the competitors' behalf by the Organizers. The order form can be downloading on www.abudhabidesertchallenge.com

The cost of these devices is <u>NOT</u> included in the Entry Fee and must be paid directly to ERTF. ERTF will request a deposit of €1700 for the material.

2023 SR 080.29.1. 2. Inflatable jacket and other protections.

The wearing of a waistcoat or airbag jacket and the chest protection are compulsory during every stage.

The products used must have been certified by the FIM.

The Rider must take a spare cartridge for his inflation wait coast with him.







The neck brace is not compatible with the airbag and is therefore prohibited. The list of airbags is available here:

2023 SR 080.29.1 3. Tracking System

ADDC needs to use Marlink official supplier of the tracking system for the W2RC. If you are not familiar with their Iritrack system, it is advised that you visit their resource page below on the Marlink website and or contact them below with any question. Additional information will be provided at the competitors briefing and in the supplementary regulations in regards to the operation of the Iritrack system or can be found in the 2023 FIA Cross Country Rally Sporting Regulations, Appendix V1, Section 12.1.1.

The rental cost of the Tracking/Safety system (Iritrack V3) and Timing system has been integrated into the Entry Fee.

However, for Iritrack V3 you will require to purchase a mounting kit with one of two options below.

- Purchase a complete mounting kit online (Power cable, bracket, antennas) from the Marlink Eshop. Shipping is possible to the UAE in approximately 3-4 days.
- Purchase the complete mounting kit at the administrative checks. In case you choose
 this method, please be aware that you may have little time to set it up before your
 allotted time for scrutineering.

Installation of the mounting kit, your vehicle must be fully equipped with the iritrack kit at the technical checks and ready to plug the Iritrack in. You can find more information and mandatory instructions in the mounting guides provided on the Marlink website mentioned above.

Deposit

Competitors will be required to lodge a deposit of €1500 at event registration to Marlink directly; afore-mentioned deposit will be reimbursed upon the safe return of the Tracking and Timing Equipment in the Documentation room.

2023 SR 080.29.1. 4. Safety Plan

The safety of the competitors is under the control of the well-established and experienced Desert Challenge Search & Rescue Team who coordinates the welfare of all riders based on information received through the tracking system, marshal and competitor communications.

They control three dedicated helicopters, the sweep team and a medical team composed of all the required specialties. Three local hospitals are alert and on standby with ICU reserved for event casualties.

A clinic is situated at the bivouac which is manned 24 hours a day.

Riders are expected to respect the emergency protocols and available resources in a manner commensurate with the vital nature of this service.

Riders are reminded that they are responsible for their own welfare and should pay good attention to hydration which is the biggest contributing factor to emergency evacuations from the stages which in turn place avoidable stress on the system and resources.

2023 SR 080.29.1. 5. Helping at an accident

It must be remembered that ethics demands that a rider who sees that an accident has occurred must stop in order to provide assistance in the most appropriate manner until the rescue service







arrives. Also, it must be remembered that major means are implemented to shorten the intervention times.

Any rider that witnesses an accident placing another competitor in physical danger must:

- Stop,
- Press the SOS button on their tracking System,
- Establish contact with rally HQ to report the situation,
- Wait for the rescue service or another competitor to arrive, and then,
- Inform Rally HQ when that they are leaving the scene.

At the request of the competitor to the Clerk of Course on arrival at the end of the Leg before 17h00, the stopping time during the incident will be deducted from the time taken to cover the Selective Section.

Any competitor not complying with the above regulations will be reported to the Stewards who may impose penalties up to and including exclusion from the event.

It is only for the first two riders.

FIM 080.30 ENVIRONMENT

2023 SR 080.30. 1. Protecting the Environment

Each participant and/or team member is responsible for the waste generated by his team during the event.

The Organizers will provide facilities for waste and used oil collection. It is strictly forbidden to empty onto the ground waste water or oil and any infraction to this rule will be reported to the International Jury who will fine the rider responsible a maximum of **EUR 370**.

Where refueling or servicing of a motorcycle is being undertaken measures must be taken to protect the ground. Participants should use environmental mats or other suitable means to cover the ground. This is also compulsory when an electrical generator or any other device with a thermic engine is being refueled or serviced by the rider or the team.

Sensitive area around the Bivouac must be respected and details will be provided at the compulsory competitors briefing on Saturday 25th February 2023.

Any infringement by the participant (who is responsible for his team) of the FIM Environmental Code can result in a fine, disqualification from the event or suspension, and may also result in the participant or rider being liable for any costs of rectification.

FIM 080.32 RETIREMENT - DISQUALIFICATION

2023 SR 080.32 1. Number plate cross out in black

In case of retirement or disqualification, the Rider has to cross out in black the number plates and the number of the race under penalty of a fine **of 500 EUR** and other possible sanctions pronounced by the FIM International Jury.

FIM 080.33 CLOSURE OF TRACK

2023 SR 080.33 1. Mechanical problem

In the event of a mechanical failure/ retirement during a Leg, in this case, you must notify the Clerk of the Course that you consider yourself to be retired on that Leg and request his permission to recover the machine or vehicle and/or receive outside assistance (Authorized







Assistance). You can wait for the Sweep/Course Closing Team to arrive and they will take you back to the bivouac.

A Rider who retires from a leg but intends to restart must hand in his time card immediately on arrival at the Bivouac. Failure to hand in the time card will incur a penalty of 5 hours.



Symbols for the Road Book











APPENDIX 5 - FIM Riders' insurance information



FIM Riders' insurance information

The rider's insurance policy set up by the FIM is a service for all the Federations that are part of the programme

for the period from January 1, 2023 to December 31, 2024.

Who is covered:

- Riders with a FIM licence issued by a Federation which is part of the FIM riders' insurance programme.
- Riders with a FIM licence issued by ACCR, DMSB, FMS, KNMV, NMF and SMF are not part of the FIM riders' insurance programme and must follow the guidelines of their respective Federation.
- Riders competing in MotoGP, Moto2, Moto3 and MotoE are not part of the FIM riders' insurance programme and must follow the guidelines of their respective Federation.
- Riders competing in a Cross Country Rally must follow the guideline of the Rally organiser.

Validity of the insurance:

- For all events on the FIM Calendar with an International Manifestation Number (IMN).
- For racing activities included in the official programme of the event only!
- Travel to and from the event venue.

Scope of coverage:

In case of racing incident, the FIM riders' insurance programme would cover:

- Emergency Medical treatment on the event's place (subsidiary and complementary to any other insurances the rider may hold)
- Repatriation to the rider's country of residence (as declared on the FIM Licence extranet by the rider's FMN)
- Death and Disability (Riders with a FIM licence issued by FFM and FMI have not subscribed this benefit from the FIM riders' insurance programme and must follow the guidelines of their respective Federation for this benefit)

Please note that this is an EMERGENCY insurance and in order to avoid any problems please follow the correct procedure.

What to do?

Before departure:

- Always check beforehand whether your personal health insurance card is still valid.
- For European citizens, please travel with your European Health insurance card.

In case of an Emergency Incident /Urgent medical assistance need:
